As part of our efforts to ensure a sustainable future, we have set ambitious climate goals aimed at reducing Martin Brower's greenhouse gas (GHG) emissions.

Transparency is an essential part of Martin Brower's efforts. To that end, Martin Brower uses internationally accepted, science-based standards in setting and evaluating progress toward its specific goals. Leveraging the Greenhouse Gas Protocol and Science Based Targets Initiative standards, Martin Brower has set net zero targets by 2050. These targets have been verified by the Science Based Target Initiative to ensure that our goals are realistic, our data is accurate, and our progress is real. ## **NET ZERO CLAIMS**

Martin Brower has set the following net zero target, approved by the Science Based Targets Initiative:

# **Overall Net-Zero Target**

The Martin-Brower Company commits to reach net-zero GHG emissions across the value chain by 2050.

#### • Near-Term Targets

- The Martin Brower Company commits to reduce absolute scope 1 and 2 GHG emissions 51.8% by 2030 from a 2018 base year\*.
- The Martin Brower Company also commits to reduce absolute scope 3 GHG emissions from fuel and energy related activities, upstream transportation and distribution, and downstream transportation and distribution 30% within the same timeframe\*.
  - \*The target boundary includes land-related emissions and removals from bioenergy feedstocks.

## • Long-Term Targets

• The Martin-Brower Company commits to reduce absolute scope 1, 2 and 3 GHG emissions 90% by 2050 from a 2018 base year\*.

As of year-end 2024, Martin Brower has reduced its Scope 1 & 2 emissions by 25% from its 2018 baseline. Martin Brower has made progress toward these goals through a number of strategies, including:

- Purchases of renewable electricity through a virtual power purchase agreement and purchases of renewable energy credits
- Utilization of biofuels in the fleet
- Deployment of battery electric vehicles in our distribution centers and on-road fleet

Progress toward these goals is based on Martin Brower's GHG emissions as compared against a 2018 baseline. Martin Brower gathers, calculates, and measures its scopes 1, 2, and 3 emissions data in accordance with the <a href="GHG Protocol Corporate Account and Reporting Standard">GHG Protocol Corporate Account and Reporting Standard</a> and the <a href="Corporate Value Chain (Scope 3)">Corporate Value Chain (Scope 3)</a> Accounting and Reporting Standard. # **SIGNIFICANT EMISSIONS REDUCTIONS CLAIMS**

Martin Brower has made the following emissions reductions claims as of year-end 2024:

- 25% reduction in absolute combined Scope 1 & 2 emissions since 2018
- 13% reduction in Scope 1 emissions globally
- 73% reduction in Scope 2 emissions globally

As of year-end 2024, Martin Brower has reduced its Scope 1 & 2 emissions by 25% from its 2018 baseline. Martin Brower has made progress toward these goals through a number of strategies, including:

- Purchases of renewable electricity through a virtual power purchase agreement and purchases of renewable energy credits
- Utilization of biofuels in the fleet

• Deployment of battery electric vehicles in our distribution centers and on-road fleet
